an you imagine what it must feel like to be abandoned as a small child by someone you love and trust? That is what happened to Enrique, one of ICC's children who grew up at the El Oasis Children's Village in Mexico.

When he was only four years old, Enrique's grandmother took him to a children's playground. To most children, this would be a joyful occasion – playing chase with other children and taking turns on the slide and swings. Imagine the extreme turn in his emotions when time passed and he couldn't find his grandmother. Where had she gone? It was getting late. The other children were going home. And still, no grandmother. Fear gripped his little heart. What could he do?Where could he go to find her – the one he trusted to take care of him?

Enrique spent the night in that playground wondering what had happened. Cold, alone, frightened, abandoned.

Enrique's experience is not unlike many of ICC's children. With their parents or grandparents unable or unwilling to care for them, they are left, dropped off, discarded as unwanted. **But not in the eyes of God! And not in the eyes of ICC family members like you!**

On that cold morning, someone with a compassionate heart found Enrique suffering, alone, and scared. He was taken to the police. After a thorough investigation and evaluation were made, Enrique became one of the first children to join ICC's El Oasis Children's Village.

Enrique was placed in a loving family at El Oasis and was supported by the generosity of ICC family members like you. He grew up at El Oasis, attended primary school, graduated High School and eventually received his degree in computer science engineering. He now works in a responsible position providing technical support within a major brand of convenience stores across Mexico. What a transformation Enrique experienced! From being unwanted and discarded, to being loved and helping to support others!

When asked what message he would like to share with those who are supporting El Oasis, Enrique had this to say. "Thank you for all you have done for me, in particular, for my education, food, a roof over my head, and a new family. And thank you for providing a place where I could be happy. I thank God for all the help you gave me... I would want to ask you not to stop there. Please continue to support the children who are living at El Oasis. All the effort you've put in for them is going to pay off. And just like me, they will be grateful to you and thank you for the rest of their lives.

Because of the care you provide to ICC children, their lives are being transformed. And like Enrique, they are grateful for all you do for them. Thank you!

Tennessee Girl Leads Sabbath School Project for Congo Family by Wendy Clark

t International Children's Care (ICC), we often say this is God's *ministry*—and time and again, He proves it through the creativity and generosity of donors around the world, people who hear His call and respond in unique ways to care for orphans.

One recent example comes from 16-year-old Edith Dietrich and her family from the Brayton SDA Church in Graysville, Tennessee. After meeting an ICC representative at the Michigan Camp Meeting and signing up for this monthly newsletter, they began learning more about ICC's mission and children's villages.

The Dietrich family attends a children/youth Sabbath School class at their small church, which regularly participates in mission projects. When it came time to choose a new cause, Edith's mom suggested helping ICC. After a phone call with ICC staff to discuss current needs, the class decided to support a house family at Patmos Children's Village in the Congo.

Edith took the lead and created a colorful mission board for the project. She listed essential needs like housing, clothing, school supplies, and bedding. On one side of the board, she posted slips marked with \$10 donation amounts—small, achievable goals that added up.

Each week, the class of 5-10 people brought in gifts. Over time, their donations grew to several hundred dollars—enough to make a real difference for a house family in Congo.

Some may feel that their contributions are too small to matter. But like the young boy's lunch of loaves and fishes, God blesses and grows every gift given in faith. Thank you to all who answer His call to support orphans through ICC!

A Giving Story Income, Taxes & Legacy

John and Sue, both in their early 60s, are preparing for retirement and reviewing their financial options. They're considering how best to manage taxes and future income from their real estate, stocks, and retirement accounts.

The couple has a deep love for children and a desire to live out James 1:27 by caring for orphans and widows. Confident their retirement needs will be met, they hope to use their surplus assets to make a lasting impact by supporting ICC.

They expect income from Social Security, IRAs, and other retirement plans, but additional funds will need to come from their appreciated real estate and joint investment accounts. Selling those assets outright would trigger significant capital gains taxes.

Their advisor recommended a Charitable Remainder Trust (CRT) as a smart solution. By transferring real estate and stocks into a CRT, they receive a lifetime income stream, avoid capital gains taxes, and earn an immediate partial tax deduction. These assets are also removed from their estate, reducing or eliminating estate taxes.

John and Sue are grateful. The CRT allows them to reduce their tax burden, secure their retirement income, and create a future legacy for ICC's children.
