I never felt like I was alone with so many children around who were like me. I never lacked anything here, and I never felt homesick. My first impression of this place was that I felt more peace and joy. I loved my stay over the past years and still enjoy serving my home where I grew up.

When I was a child, all the Sweet Home children were taken for a three-day camp. We enjoyed the meals very much and visited the lighthouse near the beach. We had singing and praying sessions every morning during our stay. We never forgot God wherever we were taken to. I enjoyed playing in the water and building sand houses. It was a memorable incident in my life. I will never forget or take it out of my mind.

Currently I'm accomplishing the duties of Children's Services Director. I'm happy to work for my own family with my siblings at Sweet Home. I'm enjoying all the activities which are done here. I advise my siblings to depend on God and always to pray to God. I also advise them to do what is right in the sight of God and men. I pray for them and for the development of Sweet Home and for all the working staff. I always pray to God that He will not stop providing for the children like me.

I pray, hope, and dream that all the children will have all their needs met according to the providence of the Almighty God. I pray that everyone will study well and work hard and achieve their goals.

I'm always thankful to ICC Sweet Home for supporting me in everything. Without their help, I am nothing today.
